- 2. Details of the Vessel:

- 3. Objectives: In accordance with the Company's strategy to rejuvenate its fleet by selling its older vessels and acquiring younger and bigger vessels. This Vessel is old and therefore, has been sold.
- 4. The counterparty and relationship: The Buyer is a company incorporated in Singapore, which does not have any relationship with the Company.
- 5. Sale Price of the Vessel: The sale price of the Vessel is USD 1.51 million, which is market price.
- 6. Payment Terms: 50% of the Sale Price of the Vessel was deposited to the Seller's nominee account as deposit (pursuant to the execution of the MOA) and the balance of 50% of the Sale Price was paid on delivery of the Vessel along with the deposit, which has been released to the Seller on delivery from nominee account.
- 7. The total value of transaction: According to the Notification of the Stock Exchange of Thailand regarding Acquisition and Disposition of the Assets, the transaction is to be computed as follows:

Value of assets disposed is USD 1.51 million:

= THB 52.63 million (Exchange Rate applied THB 34.852/1USD) / Value of the Company's Total Assets* = THB 32,457.82 million = about 0.16%
