1. Date of transaction: On 19 April, 2016, the Seller completed the signing of the Memorandum of Agreement ("MOA") for selling the Vessel with the Buyer.

2. Details of the Vessel:

- 3. Objectives: In accordance with the Company's strategy to rejuvenate its fleet by selling its older vessels and acquiring younger and bigger vessels. This Vessel is old and therefore, has been sold.
- 4. The counterparty and relationship: The Buyer is a company incorporated in Nevis, which does not have any relationship with the Company.
- 5. Sale Price of the Vessel: The sale price of the Vessel is USD 1.38 million, which is market price.
- 6. Payment Terms: 20% of the Sale Price of the Vessel was deposited to the Seller's nominee account as deposit (pursuant to the execution of the MOA) and the balance of 80% of the Sale Price was paid on delivery of the Vessel along with the deposit, which has been released to the Seller on delivery from nominee account.
- 7. The total value of transaction:

According to the Notification of the Stock Exchange of Thailand regarding Acquisition and Disposition of the Assets, the transaction is to be computed based on the Book Value which is higher than the Sale Price as follows:
