Subject : Reporting on the last exercise of Warrants to subscribe to Ordinary Shares in the Company (PSL-W1)

8.2 The relevant Warrant or the relevant substitute warrant certificate issued by Thailand Securities Depository Co., Ltd.;

8.3 Required Identification Documents

- 1 Thai Individuals: A certified true copy of valid identification card or governmental office identification card/ state enterprise officer identification card, together with a certified true copy of the house registration (in case of any change in name/ surname which causes the name/surname to be different from the name/surname appearing on the Warrant, the copy of any document issued by a governmental authority e.g. marriage certificate, divorce certificate, certificate of name/surname change, etc. must be enclosed.)
- 2 Non-Thai Individuals: A self-certified true copy of a valid foreign Passport or a self-certified true copy of any other valid identification card issued by a governmental authority which is in English (or a certified translation if not in English).
- 3 Thai legal entities:
 - 3.1 A certified true copy of the affidavit issued by the Ministry of Commerce for a period of no longer than 6 months prior to the respective Exercise Date, duly signed by the authorised signatory(ies) and affixed with the seal of such legal entity (if any); and
 - 3.2 A certified true copy of the documents specified in Clause 1 or 2 (as the case may be) of the authorized signatory(ies) who certifies true copy of the documents above.
- 4 Non-Thai legal entities:
 - 4.1 A certified true copy of the certificate of incorporation and/or affidavit of such legal entity in English(or a certified English translation if not in English), duly signed by the authorized signatory(ies) and affixed with the seal of such legal entity (if applicable); and
 - 4.2 A certified true copy of a valid passport of the authorized signatory(ies) who certified the documents under item 4.1.

The documents specified in 4.1 and 4.2 must be notarised by a notary public no longer than 12 months prior to the respective Exercise Date.
